The HKIS QSD Annual Dinner is an annual event, which provides precious opportunity for our members to mingle and meet their learned friends from the surveying profession, other professional institutions, and government officials, as well as to make new friends.

This evening, it is our pleasure to have Mr. Eric S C Ma, Under Secretary for Development of the Government of the Hong Kong Special Administrative Region as our Guest of Honour. We also have the honour of the company of our honourable guests, sponsors, HKIS President and fellow members.

At the beginning of my term as Chairman of the QSD, I have set some major tasks of the QSD to be accomplished this year. It is over half of my term and the QSD have achieved various tasks, namely, Assessment of Professional Competence (APC), New Members Welcoming Party, Continuous Professional Development (CPD) and Prequalification Structured Learning (PQSL) Events, Pacific Association of Quantity Surveyors (PAQS) Accreditation, Scholarship Programme, Visits to Universities, Technical Institutes and Schools, Attending PAQS Congress, and tonight's Annual Dinner, etc. The QSD will continue to complete the remaining tasks set earlier this year.

The QSD is in the final stage of discussion with China Engineering Cost Association (CECA) for concluding the supplementary agreement for the third batch of Assessment of qualification for members of CECA and HKIS under the Reciprocity Agreement. It is anticipated that its execution by both parties will be conducted during the third quarter of this year. I hope that more quantity

surveyors from Hong Kong will be able to extend their opportunities for working in Mainland China by obtaining the qualification of PRC Registered Cost Engineer.

Cost overruns in several major infrastructure projects have recently aroused much public concerns. The QSD have raised the important role of independent cost consultant serving as a check and balance between independent team of design and cost control.

In view of the public concerns on high cost of the returned tenders for maintenance and renovation works, the OSD have mentioned in various occasions that a standard form of maintenance contract is very important for the contracting parties to follow so as to reduce the possible risks and uncertainties. In this regard, HKIS have published two standard forms of contract, namely, "Standard Form of Contract for Maintenance and Renovation Works" and "Standard Form of Contract for Decoration, Repair and Maintenance Works" according to the size and value of the maintenance and renovation works. I would suggest practitioners in maintenance and renovation works to make reference to them and recommend the clients to use these two forms.

Taking this opportunity, I would like to thank our fellow members for their continuous supports and contributions to the QSD. Your support will make the QSD grow and flourish and will also give us impetus to do better.

Lastly, I would like to express my sincere thanks to the Organizing Committee for their valuable time and effort in organizing this event. May I wish you all have an enjoyable and memorable evening.
