Meeting with the Development Bureau (DevB), Construction Industry Council (CIC), and Legislative Councillor Sr Tony Tse on Construction Innovation and the Technology Fund

The APC Assessors' Briefing 2018 was held on 28 September 2018. Over 100 assessors attended this event. Each answer script will be marked three times by assessors of various seniorities who practice in the private or public sectors, as well as in consultancies and contracting disciplines.

The ICEC-PAQS Conference 2018 was held from 16 to 20 November 2018 at the International Exhibition and Convention Centre in Sydney, Australia. Over 400 delegates from 28 countries and regions attended this conference, which was organised by the Australian Institute of Quantity Surveyors (AIQS).

HKIS has sent 18 representatives attending the Congress as well as sharing experience and latest development with QS experts all over the Pacific region. HKIS Past President Sr Dick Kwok signed a revised reciprocity agreement (RA) with the host, AIQS, to signal the two institutes' mutual recognition of professional status and membership in the PAQS Board Meeting.

HKIS has three QSD members – Sr Dr Paul Ho, (QSD Past Chairman), Sr Dr Leung Mei-yung and Mr Anthony Tse (QSD Probationer) – joined and delivered talks on BIM contract conditions, value management, and the application of BIM in the ICEC-PAQS Conference 2018.

The HKIA, HKILA, HKIP, HKIS Forum on “Lantau Tomorrow”

A Joint Institutes forum on “Lantau Tomorrow” was held on 12 December 2018 and QSD Immediate Past Chairman Sr Raymond Kam is one of the speakers. Visit to the Singapore Institute of Surveyors and Valuers (SISV), Singapore Building Construction Authority (BCA), and Surbana Jurong Consultants Pte, Ltd (SJ)

In January 2019, QSD Chairman Sr Raymong Kong led a delegation comprising QSD Vice Chairpersons Sr Amelia Fok and Sr Sunny Choi, Immediate Past QSD Chairman Sr Raymond Kam, and Past QSD Chairman Sr Paul Wong to Singapore.

They started the official visit by meeting with the CEO of BCA, BCA shared his valuable experiences on and insights into prefabricated prefinished volumetric construction (PPVC), which is similar to modular integrated construction (MIC) in Hong Kong. On 17 January 2019, the group paid a courtesy call to the SISV and were briefed on the recent developments in building information modelling (BIM) and the Security of Payment Act (SOPA) in Singapore.

To gain a wider perspective of PPVC construction in Singapore, the group next visited SJ on 18 January 2019. The hosts briefed the group on the execution plan for SJ's road map to achieve Integrated Digital Delivery (IDD) and their efforts in driving immersive virtual reality systems.

QSD has organised a series of 24 PQSL courses (including 21 talks and 4 APC workshops) to cope with the requirements of the QSD APC Scheme in the last Council year.
