PRESIDENT'S MESSAGE 會長的話

ime seems to be flying this year and we have already passed the Spring Equinox and are rapidly heading towards Easter.

This means that the future location for the HKIS Office premises is moving to the forefront of practical internal matters to be settled, given that our tenancy at the Wing On Centre expires in December 2021.

Progress on HKIS Office Accommodation

The Task Force on HKIS Office Accommodation has been hard at work on this matter. To gain comparative insights into the state of the office rental market, members of the task force devoted a considerable number of hours to visiting 11 different sites in Kowloon and Hong Kong between January and March.

I joined them on nearly all occasions, with everyone finding much of interest for subsequent discussions. Criteria for assessment included costs in addition to rent, proximity to an MTR station, the operational benefits of higher headroom and raised flooring for wiring and cables, and a location that strikes a balance between a reasonable rent and HKIS's image. In parallel, task force members approached the present landlord to ascertain the owner's views on renewing the current tenancy.

Annual Subscriptions and Donations

On other membership matters, we are moving forward with the technology enhancement of our internal IT systems to enable online payment for annual subscription as well as application fees. Unfortunately, the system will not be ready to "go live" for online subscription payments this year. Members should thus continue to make payments by cheque to the HKIS or through our affinity credit cards.

However, we are anticipating that the option of settling annual subscription fees using the more convenient online format will be available from 2022. Later, we hope to extend this and to synchronise all fee payments on the same platform.

Besides paying their annual subscription, I would also like to encourage members to make a donation to the HKIS Charitable Foundation. The Foundation is an approved charitable institution and exempt from tax under Section 88 of the Inland Revenue Ordinance. It was incorporated in April 2014 and established to provide assistance and financial support to those in need or experiencing hardship; to organise, support, promote, and engage in non-profit work and activities for the purpose of assisting the underprivileged, elderly, social disadvantaged, and other vulnerable groups in the community; for the advancement of education and relief of poverty; and for emergency relief projects, among others.

Visit by the Liaison Office of the Central People's Government

March also brought a visit to the HKIS office by representatives from the Liaison Office's Department of Educational, Scientific and Technological Affairs. Some members of the delegation were new to the Department and were interested to learn more about HKIS and the types of collaborations and exchanges undertaken by the Hong Kong surveying profession with their counterparts providing similar services in the mainland.

While Building Surveying, Quantity Surveying, and General Practice professionals in Hong Kong have mainland counterparts providing similar services, those engaged in Land Surveying, Property & Facility Management, and Planning & Development may not.

As a consequence, the latter three HKIS divisions indicated that their surveyors still found it hard to register and practise in the mainland, despite the introduction of the "Interim Guidelines for the Management of Hong Kong Engineering Construction Consultant Enterprises and Professionals Starting Business and Practising in the Guangdong-Hong Kong-Macao Greater Bay Area Cities", brought into effect on 1 January 2021.

Registration procedures in the three pilot free trade zones in Guangdong, namely Qianhai in Shenzhen, Hengqin in Zhuhai, and Nansha in Guangzhou, and the nine mainland municipalities in the Greater Bay Area were another focus of discussion. Currently these registration requirements and procedures differ, and those for Nansha have not yet been announced. Given that some professional members have already registered in the free trade zones, the HKIS asked whether top-up procedures could be introduced to facilitate registration in other Greater Bay municipalities – and vice versa with regard to the free trade zones if members are already registered in Greater Bay Area municipalities.

The issue of authentication for Hong Kong surveying firms' job references was also raised, with reflections on whether the current authentication needed from a notary public in Mainland China could be replaced by verification by the Hong Kong government and/or the Surveyors Registration Board as appropriate, given that surveying firms on the government's company lists, i.e. the Architectural and Associated Consultants Selection Board (AACSB) and Engineering and Associated Consultants Selection Board (EACSB), have already been screened.

In mid-March, the Department of Educational, Scientific and Technological Affairs also invited some building-related professional institutes and organisations to a meeting on recent changes to the HKSAR's electoral system, which I attended on behalf of the HKIS.

Looking Ahead

April now promises to be an equally busy month as we aim to come to a decision on HKIS's accommodation and explore arrangements for a discussion forum between HKIS members and the Development Bureau to communicate views and further issues related to the facilitation of professional registration processes in the Greater Bay Area.

PRESIDENT'S MESSAGE 會長的話

▶ 光飛逝,今年一轉眼間春分已過,復活節 ▶ 又快將到來。

學會位於永安中心現址的租約將於 2021 年 12 月 屆滿,新會址何去何從已成為當務之急。

學會辦公室選址進展

香港測量師學會辦公室地點工作小組一直致力處 理此事,為更詳盡了解辦公室租賃市場現況及作 出比較,小組成員花了相當多時日,在一至三月 期間視察九龍和港島11個不同地點。

我參與差不多全部視察,而大家對後續的討論都 極感興趣。評審的標準包括租金以外的成本、與 港鐵站的距離、有否較高的淨樓面高度和足以收 藏電線電纜的高架地板以帶來營運效益,以及一 個租金相宜而又切合本會形象的地點。

與此同時,小組成員繼續與現址業主接觸,了解 業主對續租的看法。

年費與捐款事宜

在其他會員事務上,我們正致力提高內部資訊科 技系統的技術,以推出網上支付年費和申請費的 服務,可惜該系統未能趕及「上線」為本年年費 提供網上付款,會員仍需將支票郵寄至本會、或 透過會員的學會聯營信用卡支付。

我們預計從 2022 年起,會員將可選用更便捷的 網上付費方式繳付年費。我們並希望稍後能擴大 系統,將所有費用納入同一網上支付平台。

除了支付年費外,我們亦鼓勵會員捐款予香港測 量師學會慈善基金。這是認可的慈善機構,根據 《税務條例》第88條,捐款可獲免税。基金於 2014年4月成立,致力為有需要或面對困難的人 士提供援助和財政支援,組織、支持、促進和參 與非牟利工作和活動,協助貧困人士、長者、弱 勢群體等有需要人士,並促進教育、扶貧、和緊 急救助項目等。

中聯辦到訪

中聯辦教育科技部代表三月親臨香港測量師學會辦公室,該部部分新上任的成員藉此了解學會、

以及香港測量師與內地同業的合作與交流情況。

雖然香港的建築測量師、工料測量師和產業測量 師在內地有對應的相應資格,但從事土地測量、 物業設施管理、規劃及發展的測量師則未必有對 口單位。

因此,儘管《香港工程建設諮詢企業和專業人士 在粤港澳大灣區內地城市開業執業試點管理暫行 辦法》已於2021年1月1日生效,本會這三個 組別都指出,他們的測量師仍然感到較難透過備 案方式在內地執業。

討論的另一個焦點,是廣東三個自由貿易試驗區 (包括深圳前海、珠海橫琴和廣州南沙)以及大 灣區九個城市的備案程序問題。目前各地的備案 要求和程序不一,南沙自貿區的備案程序仍未公 佈,而由於本會部分會員已經在自貿區備案,因 此我們在會面中特別查詢引入銜接程序的可能 性,希望會員可以更簡便地在大灣區其他城市備 案;反之,若然會員已在大灣區城市備案,其備 案地位能否引伸到自貿區,亦在我們垂詢之列。

另一談及的事項,是關於香港測量公司參與項目 的認證情況。由於在特區政府建築及有關顧問公 司遴選委員會 (AACSB) 以及工程及有關顧問公司 遴選委員會 (EACSB) 顧問公司名冊上列出的測量 公司,已全部經由政府核實,因此我們在會面中 探討是否可以改由特區政府和/或測量師註冊管 理局作出相關認證,以取代目前必須由中國內地 公證人作出認證的做法。

三月中,教育科技部亦邀請與建築有關的專業學 會及機構就香港新選舉制度會面,我代表學會參 加會議。

未來計劃

四月將會繁忙而充實,我們希望就學會辦公室選 址作出決定,亦會致力探討安排本會會員與發展 局透過論壇討論,就促進大灣區專業註冊流程的 觀點和其相關議題進行交流。

Pilot scheme opens door to careers in GBA

Since January, the Department of Housing and Urban-Rural Development of Guangdong Province has implemented a raft of new measures under the Interim Guidelines for the Management of Hong Kong Engineering Construction Consultant Enterprises and Professionals Starting Business and Practising in the Guangdong-Hong Kong-Macao Greater Bay Area Cities, which allow enterprises and professionals (including quantity, building and general practice surveyors) to start businesses and practising in the nine cities of the Greater Bay Area (GBA). The Development Bureau of Hong Kong said it would continue to discuss with relevant mainland authorities to explore other opportunities for Hong Kong professionals to work on the mainland.

The Hong Kong Institute of Surveyors (HKIS) welcomes the implementation of the Interim Guidelines and believes that it will attract more surveyors from Hong Kong to expand their business and practice in the GBA, which in turn will also help improve the efficiency and quality of construction and management of real estate in the mainland. In fact, the HKIS and other professional bodies have been promoting mutual recognition of professional qualifications between the mainland and Hong Kong for years and expressing opinions to the mainland's authorities and professional bodies from time to time.

Sr Wendy Cheung, Chairman of the HKIS Shanghai Forum, is a quantity surveyor by profession, which is equivalent to mainland's cost engineer. She recalls that since 2003, three batches of quantity surveyors from Hong Kong have obtained registration certificates of cost engineer of the People's Republic of China as well as a practicing seal of registered cost engineers issued by the Ministry of Housing and Urban-Rural Development of the People's Republic of China. Hong Kong quantity surveyors who have obtained registration certs (Hong Kong SAR) and practicing seals can conduct business in the name of cost engineer in the mainland.

"Back then, to obtain the certification, we had to participate in training courses and pass a qualifying exam. But this pilot scheme that allows Hong Kong surveyors to practise in the GBA directly is much simpler. Working in the GBA is increasingly appealing to Hong Kong professionals, including surveyors. In the past decade when China's firsttier cities such as Shanghai or Beijing grew more rapidly, surveyors choosing to work across the border either had to leave their family for a long time, otherwise they would have to relocate with the whole family. However, the GBA is geographically much closer to Hong Kong. I believe the pilot scheme can attract more surveyors from Hong Kong, especially younger ones, to develop their career in the mainland."

GBA's development activity set to increase over the next decade

Sr Cheung started working in Shanghai in 2006. At that time, Shanghai was preparing to host the World Expo 2010 and so there were many construction projects. Opportunities abounded for surveyors. She believes that major development activities will concentrate in the GBA in the next ten years, offering another round of opportunities for surveyors from Hong Kong.

In terms of differences in practices between working as quantity surveyor as opposed to cost engineer, she says there are minor differences between the "bill of quantities" used in Hong Kong and "China's national bills quantities" methodologies, such as calculation methods, descriptions and classifications. Each of them has its own advantages. Yet, she emphasises that the ultimate goal is to effectively manage and control costs and properly handle contractual matters.

She says: "Property developers from Hong Kong or abroad tend to recognise the service principles of Hong Kong surveyors more. In addition to faith in our professionalism, our services are also more comprehensive. For example, our full scope of cost consulting services begins in the early stage of the development cycle, from feasibility studies throughout the entire project until the end of the settlement and defect warranty period. We keep track of the whole cost management process. This is very different from the phased participation of cost engineers in China in the past, and this is where our advantage lies."

"Most multinational and Hong Kong QS firms are very supportive of Hong Kong graduates or graduates returning from overseas by offering them internship opportunities. From my observation, these young grads are quite open to new things and are willing to adapt to the local culture. They are willing to socialise after work. That said, since Shanghai is a few hours' flight from Hong Kong, not many stay on after the internship. The GBA is much closer to Hong Kong, which is very suitable for Hong Kong grads interested in working in the mainland."

Keep an open mind and work hard

Sr YL Wu, Chairman of the HKIS Beijing Forum, moved

to Beijing in 2006, a critical time as Beijing was due to host the Beijing Olympics in 2008. Building professionals, such as surveyors, were in demand. Sr Wu is a building surveyor, and he obtained his China's supervision engineer qualification through training under the first batch of mutual recognition scheme. In consideration of cost effectiveness, and due to the extensive liability risks posed to supervision engineers, foreign and Hong Kong developers tend to outsource supervision work to local firms. Building surveyors from Hong Kong working in the Chinese mainland often play overall management and coordination roles.

Coupled with the country's drive towards net zero with green buildings, he believes that the future development of the GBA is a prime opportunity for Hong Kong surveyors. "In the next few years, there will be a lot of construction works in the GBA. Take green buildings as an example; the whole development cycle requires the participation of surveyors from various disciplines. For young surveyors, they can get greater exposure to different expertise and practices and gain valuable experience in just a few years."

It is really a challenge for Hong Kong surveyors to practice their profession outside Hong Kong, a place where they are familiar with; however, in the long run, they can definitely reap the rewards of their hard work and the benefit of an early entry to a new market, although the initial remuneration package may not be as favourable as expected says Sr Wu candidly. In reality, building and surveying professionals in the mainland have gained much experience from the Belt and Road projects. They are more competitive internationally than before.

Surveyors wanting to develop their career in the mainland or the GBA must adhere to the highest professional ethics, he advises. Furthermore, they must work hard, respect the local culture, speak Mandarin well, understand local regulations, and learn how local government agencies work.

"While Hong Kong surveyors have an international exposure and a reputation for professional ethics and integrity, we must have a strong sense of responsibility in order to stay competitive. Less experienced surveyors can first consider the GBA cities where language, culture and geographical locations are closer to Hong Kong's. Furthermore, I also hope that the government and the industry can devote more resources to train and encourage young surveyors to work in the GBA. After a few years' time on the ground, they will be able to stand on their feet."

Mainland work experience matters

The business focus of Sr Paul Cheung, Chairman of the HKIS Guangzhou Forum, covers southern China, including the GBA. By profession, he is a general practice surveyor and the corresponding qualification in the mainland is real estate appraiser. As early as 2003, the HKIS signed a mutual recognition of qualifications with the China Institute of Real Estate Appraisers. He says the application procedure for the pilot scheme is simpler, and approval can be obtained in a short time after submitting credentials online.

"In the past, surveyors who were sent to work in the mainland on assignments were more senior, more experienced. However, I believe that the opening of applications for direct practice across the border through this scheme will attract more middle-level surveyors to work and gain experience there. As salary levels of mainland professionals continue to increase and catch up with Hong Kong's, job opportunities in the mainland are increasingly attractive."

Hong Kong surveyors are more flexible in adapting to a new work culture while having an international recognition, professional ethics and integrity. These advantages give project owners and institutional investors a great deal of confidence. Having said that, those who are new to working in the mainland must adjust their mentality, spend time to understand the local laws and regulations, as well as the business culture. They must remain professional and calmly work through difficult situations, he advises.

When it comes to the differences in real estate market maturity, he says in recent years local governments have been gradually improving market governance and transparency. Market information has become more transparent. Hong Kong surveyors should find it easier than ever to conduct due diligence for their valuation and consulting works.

Last but not the least, he reminds HKIS members planning to station in the mainland for a long time to pay attention to how they pay taxes in future. Under China's new tax law, China tax residents fall into one of two groups: China domiciled and non-PRC domiciled who stay in China for 183 days or more in a tax year. When either criterion is met, an individual is regarded as a Chinese tax resident and subject to tax on worldwide income.

《暫行辦法》開啟大灣區 執業方便之門

自今年一月起,廣東省住房和城鄉建設廳實施《香 港工程諮詢企業和專業人士在粤港澳大灣區內地 城市開業執業試點管理暫行辦法》,讓香港企業 和專業人士(包括工料、建築及產業測量師)能 於註冊登記後於大灣區九個城市執業。香港發展 局表示將會繼續與內地相關單位商議,探討推出 更多合適措施。

香港測量師學會對新措施表示歡迎,認為能夠吸 引更多本地測量師到大灣區拓展業務及執業,借 鑒香港的經驗和做法,進一步提升內地項目建造 及營運的效率和質素。而事實上,學會及其他專 業團體多年來一直推動內地與香港專業資格互相 認可,不時向相關部門反映意見,以及與內地政 府部門及專業團體交流。

學會上海議會主席張麗娟測量師本身是工料測量 師,對應內地的專業資格為造價工程師。她憶述, 自2005年,曾有三批來自香港地區的工料測量 師,獲國家住房和城鄉建設部頒發《中華人民共 和國造價工程師註冊証書》及註冊造價工程師執 業印章。獲得造價工程師〔香港地區〕資格的香 港工料測量師,可於國內以造價工程師的名義提 供業務。

「當年而言,我們須參加由內地單位舉辦的培訓 課程,經考核後才能取得國內的專業資格。相比 之下,這個大灣區執業試行計劃簡單多了。相信 香港的專業人士包括測量師在內,會因而被吸引 到內地工作。從前,要到內地其他主要城市長駐 或工作,至少要獲家庭體諒,甚至要全家一起過 來,但大灣區地理位置鄰近香港,即日來回也相 當方便,我相信計劃可吸引更多香港的測量師, 特別是年輕一輩,到內地發展。」

未來十年 大灣區勢成建設重點

張麗娟測量師於2006年開始到上海工作,適逢當時上海準備舉辦世博會,有許多建設項目,機會處處。她認為,未來十年大灣區將有大量重點工程建設發展,建議香港測量師好好把握這個機遇。

談到香港工料測量師與內地造價工程師在實務上 的分別,以港式清單與國標清單分別為例,兩地 專業在計價方式、清單描述及分類等操作上有所 不同,各有優點,她強調,最終目的都是為了有 效管理成本和妥善處理合約事宜。

她說:「港資或外資背景的發展商,比較認可來 自香港的測量師的服務理念,除了相信我們的專 業操守外,我們的服務亦較全面,例如全過程造 價諮詢服務,從前期可行性研究階段開始參與, 一直貫穿整個項目至結算與缺陷保修期結束,全 過程動態跟蹤,這跟內地造價工程師分階段參與 的服務模式有所不同,各展所長,也是我們優勢 所在。」

「跨國或香港的工料測量師行,大多很支持香港 的學生或海外回流的學生到內地實習。我留意到 這幾年來上海實習的學生,他們大都樂意接受新 事物,適應能力強,也很喜歡跟不同的人接觸, 瞭解本地的生活文化。但由於上海距離香港較遠, 實習完留下來工作的不多,但大灣區鄰近香港, 很適合有志於內地工作的畢業生。」

虛心學習 刻苦耐勞

至於學會北京議會主席胡煜琳測量師也是大概於 2006 年左右到北京長駐,一直至今,適逢當時北

京正籌辦京奧,大興土木,對建築 測量人員需求殷切。他本身是建築 測量師,而他是透過第一批互認計 劃及培訓,獲得了中國監理工程師 的資格。但他坦言,由於成本效益 及內地監理責任風險廣泛,外地及 港資發展商多會將監理工作外判予 當地監理,統籌及監管則由香港的 資深建築測量師擔任。

他認為,大灣區未來發展,加上國 家推動零碳排放及綠色建築,是香 港測量師難得機遇。「未來幾年, 大灣區將會有很多建設,就以綠色 建築為例,整個建築周期裡需要不 同範疇測量師的參與,對於年輕的 測量師來說,可以學到很多其他的 範疇的專業知識,幾年內可以累積 到許多寶貴經驗。」

但胡煜琳測量師坦言,對於香港測量師來說,在 他們熟悉的香港以外的地方實踐專業,確實是一 項挑戰。但從長遠來看,即使最初的薪酬待遇可 能不像預期,但肯定可從辛勤的工作中獲得回報, 早著先機,進入大灣區這個龐大市場。而事實上, 內地不少建築及測量專業人員,或多或少已從一 帶一路項目取得了豐富的海外經驗,國際市場的 競爭力遠勝從前。

他勸勉有意到內地或大灣區發展的測量師,除了 要保持最高的專業操守和誠信之外,也要刻苦耐 勞,尊重本地文化,説好普通話,認真學習和掌 握本地的法規和政府的工作流程。

「香港的測量師本身具備國際視野,專業操守信 譽良好,但我們也一定要有很強的責任感,才能 於內地保持競爭優勢。經驗不多的測量師,可以 先考慮到語言文化和地理位置跟香港接近的大灣 區發展。我希望政府及業界能投放多一點資源, 培訓及鼓勵年青測量師到大灣區工作,當他們多 累積幾年經驗並掌握內地的工作情況後,便能夠 上軌道。」他說。

累積內地工作經驗 增強競爭力

學會廣州議會主席張子濤測量師管理的業務集中 於華南地區,包括大灣區。他本身的專業是產業 測量師,內地對應的專業資格為房地產估價師, 而學會早於 2003 便與中國房地產估價師學會簽



訂資格互認。但他指出,是次大灣區執業試行計 劃申請辦法簡單,網上提交資料後很快便可獲得 審批。

「以往獲公司派駐內地工作的測量師,一般為較 資深的管理層,但我相信內地執業資格開放申請 後,能吸引資歷較淺的中層員工上來,累積內地 工作經驗,增強自身競爭力。隨著內地專業人士 的薪酬水平不斷提升,內地工作機會對香港測量 師有一定吸引力。」

他續說,香港測量師適應能力強,在國際上也有 認受性,具專業操守和誠信,能給予業主和機構 投資者信心。話雖如此,剛到來工作的同事,心 態上要有所改變,花時間了解內地的法規、文化 與港不同,處事要懂得從宏觀的角度來考慮。

談到內地與香港房產市場制度和成熟程度不同, 他指出近年國內地方政府已逐步完善房地產市場 監管制度,市場資訊透明化,香港測量師要為客 戶進行物業估價或提供顧問服務時比從前更得心 應手。

最後,他提醒有意到內地長期工作的會員,要注 意生活細節上的接軌,例如税務安排。根據內地 《新税法》,規定在中國境內有住所、或無住所 但在一個納税年度內在中國境內累計住滿 183 天 的個人,都屬於「税務居民」,需要就中國境內 和境外取得的所得繳税。

国内新闻分享

助力碳达峰、碳中和,装配化装修市场 前景广阔

碳达峰、碳中和相关话题持续引发关注。今年政府工作报告提出,要扎实做好碳达峰、碳中和各项工作,优化产业结构和能源结构,促进新型节能环保技术、装备和产品研发应用,培育壮大节能环保产业。

碳达峰及碳中和政策目标的提出,对传统建筑行 业加快转型升级提出了新的要求,同时也给装配 式建筑等行业带来了更大的市场机遇。以装配化 装修为例,一体化设计、预制式生产、装配化安 装、信息化管理,不仅能有效减少现场施工带来 的噪声及粉尘污染,同时也将大范围降低碳排放。 随著碳达峰与碳中和各项工作的推进,装配化装 修在绿色环保等方面的综合优势将进一步凸显, 行业发展也有望提速。

事实上,近年来装配化装修已越来越受关注和重视。3月11日,住房和城乡建设部标准定额司 发布的《关于2020年度全国装配式建筑发展情况的通报》显示,在装配式建筑产业链中,装配 化装修成为新的亮点,2020年装配化装修面积 较2019年增长58.7%。多家机构的研究报告也 指出,虽然我国装配化装修起步较晚,但已处于 快速增长中,碳达峰与碳中和发展目标的提出将 进一步促进装配化装修产业的发展,预计到2025 年市场规模有望突破6000亿元。

碳中和目标下装配化装修价值凸显

为应对气候变化,2020年9月,我国作出"二氧 化碳排放力争于2030年前达到峰值,努力争取 2060年前实现碳中和"的庄严承诺。在今年的政 府工作报告中,"扎实做好碳达峰、碳中和各项 工作"被列为2021年重点任务之一。

碳中和目标下,装配化装修价值凸显,在助推传 统建筑行业加快转型升级方面作用重大。近年来, 国家层面已有多份文件为装配化装修发展"指路"。2016年9月,国务院办公厅印发的《关于大力发展装配式建筑的指导意见》提出,要积极推广标准化、集成化、模块化的装修模式,促进整体厨卫、轻质隔墙等材料、产品和设备管线集成化技术的应用,提高装配化装修水平。2017年3月,住房和城乡建设部发布的《"十三五"装配式建筑行动方案》也提出,要加快推进装配化装修,提倡干法施工,减少现场湿作业,要推广集成厨房和卫生间、预制隔墙、主体结构与管线相分离等技术体系。

传统装修方式存在现场环节多、工种多、人工作 业依赖严重、耗时久、质量难以保证等问题,相 比之下,装配化装修具有"多快好省"的特点。 兴业证券的一份研究报告称,从项目运作流程看, 装配化装修的方案和施工阶段前置,实现了与建 筑方案同步设计、施工;从产品角度看,装配化 装修的工业化思维设计理念将八大装修模块拆分 成多种部品部件,装修公司对每种部品部件提供 若干选项,由此形成了标准化中的个性化;从建 造环节看,工厂部品生产不影响工程进度,现场 安装又要求全部采用乾法施工、没有二次加工, 施工周期比传统方式大幅缩短;从材料角度看, 装配化装修采用矽酸钙复合板、岩棉等环保材料, 相比传统装修更环保,同时材料用量也大幅减少; 从运维角度看,后期部品部件更换维修便捷,维 护成本相对较低。

和能人居科技集团相关负责人也表示,装配化装 修采用的材料通过工业化生产,并应用先进的技 术工具及理念,有利于提升建筑的品质。此外, 装配化装修还可以缓解建筑业用工紧张问题和环 境压力,助力装配式建筑"增分不溢价"。

装配化装修除了具备上述优势外,它还是"增分"的关键。2018年2月1日开始实施的《装配式建筑评价标准》明确,装配式建筑宜采用装配化装修。根据该标准,装配率不低于50%可评定为装配式建筑,其中,60%~75%可评为A级,76%~90%可评为AA级,90%以上可评为AAA级。根据评分标准,与装修相关的分值大约为45分,分布于墙体和装修管线两大类别下,如果主体结构方面的分数难以大幅提升,那么装配化装修将是一个重要突破口。

装配化装修成诸多企业拓展的市场重点

装配化装修处于装配式建筑建造过程的"末端", 相较于预制构件生产、主体结构施工等环节,装 配化装修受到市场重视和关注的时间并不长。但 在众多利好条件的加持下,目前装配化装修已在 长租公寓、保障房、快捷酒店、办公楼等领域得 到大量运用,并不断向中高端住宅领域扩张。对 于未来装配化装修的市场前景,多家研究机构表 示看好这一市场。

兴业证券的研究报告表示,虽然装配化装修起步 较晚,但已处于快速增长中。假定每平方米的装 修单价为2000元,对应2018年、2019年装配 化装修市场规模分别约为140亿元、906亿元, 据此测算,2025年装配化装修市场规模将达到 6327亿元。

华泰证券的研究报告也预计,2025年装配化装修 市场规模将达到6390亿元,2020年~2025年的 复合增速约为33.43%;另外,2025年装配化装 修的建筑面积在新建建筑面积中的占比可达12% 左右。

面对这一巨大潜在市场,近年来已有不少传统装饰装修企业以及房地产开发企业开始陆续布局装配化装修领域。其中,和能人居科技集团自2005年立项研究装配化装修系统解决方案以来,经过十几年的研发实践,已完成装配化装修研发一设计一生产一施工一运维一培训等全产业链布局, 并形成了满足全屋装配化装修的12大系统。

苏州柯利达装饰股份有限公司在稳步发展主业的 同时,也从2020年开始进军装配化装修市场。 目前,该公司完成了装配化装修八大系统的研发, 构建了部品部件标准库。"根据行业的发展趋势, 装配化装修将成为公司今后的重点发展方向,我 们将在装配化装修的设计、生产、施工过程中扩 大规模,并面向全国拓展业务,争取在2021年~ 2023年分别实现装配化装修产值20亿元、30亿 元和45亿元。"该公司相关负责人表示。

近年来,在装配式建筑领域持续发力的美的置业, 通过旗下深耕绿色智慧人居产业的子公司——睿 住科技也及时推出了"睿住班邸"装配式内装系 统。据介绍,该系统具备高度可变性和适应性,可结合建筑、室内设计的不同功能,采用模块化施工结构,在不同场地组装,达到容易拆卸的目的。

不过,当前装配化装修行业仍处于早期探索阶段, 存在的一些问题还需不断完善。华泰证券研究报告 认为,当前装配化装修存在消费者接受度不高、主 体施工难度大等问题。兴业证券的研究报告也认 为,当前装配化装修行业发展在顶层设计等方面还 有待完善。"首先,标准化是装配式技术大规模发 展的前提,当前装配化装修的技术标准尚未统一; 其次,部品部件供给不足是装配化装修价格高、个 性化程度低的主要原因;最后,装配化装修起步晚、 发展迅速,用户口碑的积累需要时间沉淀,产品还 需根据用户体验不断进行改善。"





Pilot Scheme for Charging Land Premiums at Standard Rates to Redevelop Industrial Buildings (the Scheme)

On 15 March, the Lands Department issued a practice note (PN No 1/2021) on the implementation of the highly-anticipated standard rates land premium. The Scheme was discussed at length and generally well-received by members during the GPD Council meeting held on 17 March.

On 19 March, the Development Bureau expressed its gratitude for the constructive advice provided by the Institute, in particular the wise counsel given by the GPD in person and in writing. The Bureau looked forward to the participation of industrial players in this revitalisation drive and encouraged President Sr Edwin Tang to relay this message to his members.

Career-sharing Session with PolyU Students



John Siu, Managing Director of Cushman & Wakefield, kindly shared with members his insights into the Hong Kong Data Centre market during a CPD event, "Demystify the Hong Kong Data Centre Market," on 25 March. He highlighted the characteristics of the market's stakeholders – investors, operators, and owner-operators – and the fundamentals of this property sector. After comparing Hong Kong's ranking to that of other APAC cities, he emphasised that, among other things, low power costs and high voltage power requirements are determining factors in data centre development. Scrutinising the relatively short development history, John assessed those major transactions that included government land sales and successful conversions/redevelopments of ageing industrial buildings. His informative presentation ended with a Q&A session.





New Open Data Available Soon



Open Data Available on HKMS 2.0

The Lands Department announced on its Hong Kong Map Service 2.0 Portal that most of its digital map products will be available as open data from April 2021. Open digital map data sets should facilitate Hong Kong's quest to be a better and smarter city.

Experience-Sharing on Hand Shield Tunneling Surveying (18 March 2021)

Hand shield tunneling is a trenchless method for sewer, water, gas, oil, and telecommunication pipeline installations underneath rivers, roads, railroads, buildings, and other obstacles. It overcomes the traditional limits of open trench excavation and minimises inconveniences to the public.

During the seminar on this topic, Sr Mo Kilong shared his experiences with hand shield tunneling surveying by introducing the construction procedures, sequence of the tunneling surveying methods, feasibility studies of proposed designs, and independent quality assurance checks of the surveying results.

Last, Sr Mo highlighted the essential competencies for a land surveyor to master when managing certain surveying issues during the construction process.



Property & Facility Management Division Sr Kays Wong PFMD Council Chairman

Further to the startling incidents of Covid-19 spreading at the K11 Musea and URSUS Fitness Centre, members are reminded to strengthen their inspections and control of their managed properties. They must maintain the highest standards of ventilation and environmental cleanliness, including mask wearing, social distancing, using the LeaveHomeSafe app, and other stringent measures, to minimise the spread of the virus.

Air Change/Air Purifier Requirement

To comply with the requirement on air changes or air purifiers in catering premises under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap.599F), licencees of general restaurants, light refreshment restaurants, marine restaurants, and factory canteens must provide information on their licenced food premises and upload the required certificates issued by registered specialist contractors (ventilation works category) in the Food and Environmental Hygiene Department's prescribed format by 30 April 2021.

A list of licenced catering premises that meet the required air changes per hour of at least 6 and/ or those installed with air purifier(s) that meet the prescribed specifications has been published on the FEHD website for public inspection. Members are encouraged to register if their managed properties are affected and refer to the following website for further details:

An Accreditation Panel (QS and PFM streams) comprising the PFMD's Sr Kays Wong and Sr Prof Dr James Chan was formed in November 2020. A webinar HKIS/THEi meeting was held on 19 March in the presence of the Institute's staff, graduates, students, and PFMD representatives. The Panel's visit to THEi has been arranged for April 2021. Further details will be announced to PFMD members, the Institute, and students after the Board of Education makes its decision.



Sr Paul Wong and I, as ExCom members, together with Sr Dr Stephen Lai (Chairman of the Mainland Affairs Committee), attended this meeting, during which issues regarding the registration of Hong Kong consulting firms in the GBA and the communication/experience exchange meetings between the GBA's cost engineering associations were discussed.





"Let's have a Chat about BIM" by ArchSD

The Architectural Services Department (ArchSD) organised the above event after its office hours on 12 March. It served as a platform for intelligence exchanges between consultants, contractors, and the ArchSD on the application of building information modelling (BIM). The QSD was honoured to be invited to nominate a maximum of four participants, including myself who attended the event in person. The other three HKIS representatives – Sr Sunny Choi (QSD Vice-Chairman), Sr Paul Wong (HKIS Vice-President and QSD Past Chairman), and Sr Dr Paul Ho (QSD Past Chairman) – joined the event online.

Among the various aspects of BIM discussed, the topic, "Transition of Design BIM to Construction BIM and How to Improve the Information Exchange between Different Parties," was focused in this informal exchange session. In this respect, ArchSD and its respective project team of contractors shared their experiences with the "Fu Shan Public Mortuary" and "Inland Revenue Tower". Views and opinions on BIM applications were also exchanged after the project sharing session. I shared the application of BIM to quantity surveying during project design and construction stages as well as the BIM training progress of QSD.

Online Forum on DEVB Security of Payment (SOP) Provisions

The Development Bureau (DEVB) will issue a new DEVB Technical Circular (Works), to implement the spirit of proposed Security of Payment (SOP) legislation in all new public works contracts, which will be launched this year. As practitioners gain more experience, they can help further refine the proposal for legislation for this field.

Prior to its promulgation, DEVB sought comments from various stakeholders, including the HKIS, on the draft Technical Circular, a draft booklet of SOP Provisions to reference when incorporating such terms into any relevant subcontracts. It also welcomed comments on a draft leaflet highlighting the key features of the SOP Provisions.

SMM5 (Building Works): Industry Consultation

The current Hong Kong Standard Method of Measurement (4th edition, HKSMM4) was

published in 2005. While adopting a new tabulated format as the UK's SMM7, many measurement rules of the HKSMM4 are based on previous trade practices. In recent decades, there have been vast changes to the construction industry such as the adoption of new construction materials and building components; utilisation of advanced construction technologies, particularly in prefabrication, standardisation, and mechanisation; the implementation of collaborative procurement approaches with more integration and partnership among all stakeholders; use of BIM technologies to enhance the design and construction process; and coping with the ever-changing and increasingly stringent legislative requirements. As a result, a new HKSMM5 has been prepared.

The SMM5 Committee has completed the SMM5 (building works) sections and wants to conduct an industry consultation for three months from 16 March to 15 June 2021.




